LATEST NEWS

1) Community Choice Aggregation: An Update on Sourcing Greener Electricity for Weston

At the December 3rd Special Town Meeting, Weston residents overwhelmingly approved Article 12, authorizing the Select Board to initiate Community Choice Aggregation (CCA). By purchasing the electricity supply in bulk for all Weston households and small businesses, CCA aims to provide competitive and stable electricity rates, while decreasing greenhouse gas emissions due to a higher-than-required percentage of renewably sourced electricity. Earlier this year, members of the Sustainability Committee, the Town Administration and SWAG, formed a "CCA Team" and met with several energy brokers. Having selected an energy broker, the team is looking forward to the next step: developing an aggregation plan for Weston. We'll keep you posted!

2) SWAG's Latest Campaign: Weston Plant Pollinator Alliance ("WPPA")

SWAG is getting ready to launch its next campaign: the Weston Plant Pollinator Alliance (WPPA). WPPA seeks to restore and protect habitat for native pollinators. Why is this campaign critical? Massachusetts is home to hundreds of native pollinator species, including wild bees, butterflies, moths, wasps, beetles, flies, and hummingbirds. Pollinators are critical to building climate change resilience and sustaining biodiversity, wildlife, and the overall health of natural ecosystems. However, the health and abundance of many native pollinator species are declining due to habitat loss, pesticide use, and lack of plant diversity. The WPPA will collaborate with residents, landowners, neighboring communities, and the Town of Weston to build and expand native plant communities that support a diversity of wild pollinators, especially threatened species.

Climate legislation: Send an Email to Our State Representative Alice Peisch

Governor Baker declared in mid-January that he would like MA to aim for net zero greenhouse gas emissions by 2050. By the end of January, the Senate passed a package of three climate bills, which aimed at setting the next generation climate policy. House Speaker DeLeo has shown his support for passing climate legislation but time is running out!
